## IHS Alumni Association Minutes Monday, June 14, 2021

**Meeting Called to Order**: Dale Veverka called the "in person" meeting to order with the Pledge of Allegiance. Meeting was held at IHS in the Media Room.

**Minutes from March 8th Alumni Meeting**: Minutes from the March 8th meeting were reviewed and accepted.

**Benjamin Vitron:** The Alumni Association rewards (2) \$500.00 Scholarships yearly. Benjamin Vitron, one of the recipients from the Class of 2021, attended the meeting and asked to speak. He thanked the Association and went on to share, with the members present, how much Independence Schools and its programs had impacted his life. Bob provided a 2021 YTD Financial Report. As of January 2021 there was \$7,952.00 as of June 14 2021 there was \$7,907.86 (a decrease of \$44.14) Side note: As of June 30,202 there was \$9,267.24 - after gift to school and award checks) *Income* - \$1,460.00 (+ interest) Membership dues paid: \$700.00 (13x5 years= \$520.00 and 18x1 year = \$180.00 Donations: \$760.00 : Elaine \$500.00, Irene Siska \$100.00, Bob \$120.00 (paid in lieu of bill to Association for Ohio Tax filing fee and educator certificates,4 members @ \$10.00 each = \$40.00 *Expenses* (March-June) \$1,373.45 (+ bank fees) Four checks were written: \$58.45 Rapidribbons - 50 Legacy Ribbons

**Principal's Report:** Jamie Vanek - Independence Middle School Principal was present and provided the following information:.

Spring Sports were able to be carried out . Mrs. Crooks was awarded "Coach of the Year. The Middle School was able to have a school play and talent show June 2 and 3rd. The atmosphere is positive and going forward the theme is RECHARGE and RESTART. This year Independence High School held their 2021 Commencement Ceremony outside and diplomas were presented to 69 graduating seniors.

**Discussion of Alumni Business and Upcoming Events:** Dale Veverka (70) stated that this year in lieu of singling out one educator of excellence it was decided that 207 Certificates for EDUCATOR of EXCELLENCE would be given to 207 recipients for their outstanding performance and dedication during a worldwide pandemic. These were given to the teachers, the school bus drivers, the cafeteria workers, the classroom aids, the maintenance and cleaning staff , the administrators and the administrative staff. Amber Veverka spoke about the Spring Issue of the Alumni Spectator that would be coming out soon. She asked for articles on anything that would be of interest . Also any updates on class reunions would be appreciated. She is always looking for stories about past IHS memories, etc.....

Don Krolikowski spoke about the website. He reported that between March 9th and June 14th there were 403 users, Primary views were photos and meeting minutes. He noted that 24 were removed as undeliverable.

Home Days was discussed. There was a discussion about having the ALUMNI TENT at HOME DAYS as well as having the ALUMNI BREAKFAST. It was decided NO. Don Krolikowski made the first motion and Bob Wagner made the second motion to not have the ALUMNI Association participate in HOME DAYS this year. Hopefully we can resume the tent and raffles and breakfast in 2022.

There was also some discussion about making the meetings available via ZOOM along with "in person" as there are some Alumni that live out of town and some who are unable to attend in person and they would like to be a part of the meeting.
